

THIS TRUST DEED is made the DD/MM/YEAR (the “Effective Date”), **BY AND BETWEEN**

1. The Trustees hereby declare that they hold the said benefits, future participations and profit accrued or to accrue upon trust for the Beneficiary and his successors in title and agree to transfer, pay and deal with the said assets and the benefits and interest payable in respect of same in such manner as the Beneficiary or his successors in title shall from time to time direct, upon expiration of participation period defined as above as "Expiry Date", and in accordance with Policy Conditions announced by BIG INTERNATIONAL (NEVIS) LTD.
2. The Trustees will attend all meetings or otherwise which the Trustees shall be entitled to attend by virtue of being the registered proprietors of the held assets and will vote at all meetings or otherwise which as registered proprietors of the said assets they may attend, in his absolute discretion.
3. The Beneficiary will at all times hereafter indemnify and keep indemnified the Trustees and their successors in title against all liabilities which the Trustees or they may incur by reason of such assets being so registered in the name of the Trustees as aforesaid.
